Progress Meeting

- Election To elect a Chair and Vice Chair of the Climate Change & Biodiversity Sub Committee.
 Cllr White was elected Chair of the meeting. This item was deferred to the next meeting.
- Apologies To receive apologies and approve reasons for absence.
 Apologies from Cllr Hubbard, Maitland, Rymer & P Taylor were noted.
- 3. **Code of Conduct** Localism Act 2011 to record any Councillor's Disclosable Pecuniary Interest (DPI) in relation to items on this agenda, to consider any dispensations or changes in member's register of interests. **No interests recorded.**
- 4. Matters Arising from the minutes of- 22nd February 2023. It was AGREED to relook at the Bus Shelter and finalise the area where it will be sited and agree on the next steps.
- 5. YDNPA sustainable development fund to discuss applying for funding to replace lanterns with LEDs in the National Park area of Settle.
 - It was AGREED to recommend to the Recreation & Environment Committee & Full Council that the funding be applied for.

Fiona confirmed that a decision on whether to adopt the revised Climate Change Strategy will be taken by NYC in June, following consultation feedback. The strategy will be published after approval. NYC send out a Climate Change newsletter to local authorities and groups, Fiona agreed to forward this to STC (Settle Town Council).

7. North Yorkshire Let's Talk transport survey.

NYorks Council are redoing the local transport plan. It was AGREED that Cllr Taylor would bring the survey to the attention of the Chamber of Trade in order for them to encourage local businesses to fill out the survey.

8. No Mow May – To consider an exemption for the Cemetery.

It was AGREED to recommend to the Recreation & Environment Committee & Full Council that we continue with the No Mow May campaign but the side of the Cemetery containing the graves/headstones would be excluded from the campaign and would continue to be cut.
