Dear Resident/ Proprietor,

B6480, DUKE STREET, SETTLE - RESURFACING WORKS

This letter is to inform you that North Yorkshire Council, will be undertaking carriageway resurfacing and patching works at the above location.

The works are currently programmed to commence on 16th September 2025 and will be carried out under a full road closure of the B6160 between the hours of 19:00 – 00:00 for a period of 12 weekday nights. A plan showing the extent of the works is enclosed for your information.

Outside of the working hours, between 00:00 - 19:00, there will be a Temporary One-Way System in place to prevent damage to the works from traffic. The raised ironwork will be protected by cones and/or barriers, that guide the traffic through the works, avoiding the ironwork as much as possible. All side road junctions adjoining the B6480 shall be signed appropriately to prevent traffic from going against the one way system. A plan showing this Temporary One-Way System is also enclosed for your information.

Advance warning signage advising of the works will be installed on site shortly. Whilst the works are in progress, a fully signed diversion will be in place. On-site personnel will assist in managing access to properties and businesses within the closure. Please be advised there may be extended periods when access will not be possible due to the nature of the works and physical constraints of the site. Pedestrian access will be maintained.

Emergency services access will always be maintained.

Please note, this work is part of an extensive programme and therefore, some adjustment to this start date or the duration of the works may be necessary should unforeseen circumstances such as significant weather events or emergencies on the highway network arise.

To ensure the delivery of these works we request your assistance in the following ways:

- Please contact the Customer Service Centre on 0300 131 2 131, to identify any special access needs you may have prior to work commencing.
- Please make arrangements to store your vehicle at an alternative location
- Please co-operate and comply with any instructions issued by the traffic management operatives and take extra care whilst within the works area.





NOTES:

- In order to protect the raised ironwork from damage by vehicles, a Temporary One Way System is to be put in place during the remainder of the time when the road closure is not in place. i.e. between the hours of midnight and 19:00 and all weekend.
- 2. The raised ironwork shall be protected by cones and/or barriers, that guide the traffic through the works, avoiding the ironwork as much as possible.
- All side road junctions adjoining the B6480 shall be signed appropriately to prevent traffic from going against the one way system.
